Application Type: Addition: Single Detached Dwelling (basement – front attached garage, main floor – front)

Proposed Use: Home addition

Proposed Development is: Discretionary

**Description:** The Brentwood CA has received an application for a Development Permit (DP) to allow for a 2-storey addition to the front (west side) of the existing home. The proposed footprint for this addition is about 709ft<sup>2</sup>, and consists of a 2-car garage at the basement level and living space above.

The City requires that plans be circulated only to “members of the public who would be directly affected” (i.e. neighbours).
